Contracting on Wednesdays

Wednesday is a minimum-day schedule at all elementary schools, with grades K-5 arriving at Kids' Club between 1:00pm and 1:35pm. Parents of part day kinders/transitional kinders who need care on Wednesdays must contract for a full day on Wednesdays at the full day kinder rate.

Notification of Absence

- 1) Written warning after the first "Non-Notification" of your child's absence
- 2) \$25 penalty fee will be assessed for the second "Non-Notification" incident
- 3) \$50 penalty fee will be assessed for the third and subsequent "Non-Notification" incident(s)
